#### Overview:

- To prepare the Management Accounts on a monthly basis and ensure Balance Sheets are reconciled. To maintain Cashflow and to assist with the preparation of the Budget and Forecast as necessary.
- This role will be split between working in the Southend on Sea Office

## **Key Responsibilities:**

- Preparation of the Management Accounts on a monthly basis including Profit & Loss, Balance Sheet and Cashflow. The Management Accounts should be finished and presented to the Head of Finance by the monthly deadline.
- Comparisons should be made to budget/forecast and to the previous period and this should be discussed with Operational Managers to ensure accuracy and consistency.
- Explanations should be obtained for any variances in expenditure and a commentary of expenditure should be provided on a monthly basis.
- Analysis of revenue on a monthly basis ensuring income has been accrued or deferred where necessary.
- Carrying out Balance Sheet Reconciliations for all group companies on a monthly basis.
- Assisting in the preparation of year end statutory accounts for each subsidiary company and Hood Group Limited.
- Maintaining and monitoring Group cash balances and with cashflow management.
- Preparing brand profitability and departmental profitability.
- Assisting the Head of Finance with bids profitability workings. Comparing actual
  profitability to the original bid.
- Managing the sales ledger, including raising sales invoices and ensuring debt is collected.
- Other regular and adhoc financial responsibilities including involvement in: product development, PAYE (P35/P11Ds/PSAs), FCA reporting, systems development and change management.
- Any other ad-hoc duties as required.
